## CS 105 Final Exam

Practice Final Exam, Spring 2014

In biology, messenger RNA (mRNA) is a family of RNA molecules that convey genetic information from DNA to the ribosome. Since this process is critical for protein production and gene expression, analysis on mRNA is extremely common. For the next ten questions, you will be doing some simple analysis on mRNA. Don't worry, you won't need to know anything about biology (and knowing the biology behind mRNA won't help you here!).
mRNA, like all RNA, is a series of nucleotides that are represented by the letters $\mathrm{G}, \mathrm{A}, \mathrm{U}$, and C . For example, the following string is a representation of some mRNA:

```
var mRNA = "GAAAUGCCAUUCAAAGAUUAA";
```

Instead of trying to make sense out of a long string, mRNA is often read as a series of codes. These codes are created by simply dividing the mRNA into regions that each contains exactly three nucleotides (G, A, U, or C) For example, the string introduced earlier can be divided up into these codes by looking at exactly three characters at a time:

In Champaign-Urbana, there are two airports within 60 miles:

- CMI: Willard Airport (Savoy, IL)
- BMI: Central Illinois Airport (Bloomington, IL)

Often, air prices differ significantly between these two airports allowing for a consumer to save some money by choosing one airport over another. For the next three questions, consider the following Excel sheet that lists the prices of flights from the two airports:

For this page, instead of using a meat variable to represent what meat selection was made, suppose the order comes to the computer system as an array. Suppose we define every word to have a score, where the score for the word is found by taking the first two letters of the word and:

- if the first letter has a larger ASCII code than the second, subtract one point;
- if the second letter has a larger ASCII code than the first, add one point;
- if the letters have the same ASCII code, do not add or subtract any points.

After comparing the first and second letters, move on to compare the second and third letters. After the second and third, continue with the third and fourth. This process should continue until the end of the word.

For example "HALL" scores 0 points because:

- H (ASCII code 72) has a larger ASCII code than A (ASCII code 65), -1 point
- A (ASCII code 65) has a smaller ASCII code than L (ASCII code 76), +1 point
- L (ASCII code 76) has the same ASCII code as L (ASCII code 76, 0 points
